



## LIFEGUARD INSTRUCTOR CROSS-OVER COURSE DISPATCH SHEET

**PRE-REQUISITE(S):** 1.) 17 years of age or older; 2.) current and verifiable World Academy of Safety & Health (WASH) Lifeguard Instructor certification **OR** current and verifiable lifeguard instructor authorization from another nationally or internationally recognized certifying body; 3.) current and verifiable HSI (formerly ASHI) Instructor certificate at the Basic Life Support (BLS) level and be aligned with an ASHI Training Center.

**COURSE PURPOSE:** This course is designed for lifeguard instructors with valid, current and verifiable authorization/certification/license from a nationally or internationally recognized certifying body who wish to become instructors of the World Academy of Safety & Health (WASH) Lifeguard Certification program.

The goal of this specialty instructor-level cross-over course is to develop an understanding of the basic principles of teaching and learning; develop instructional skills; and develop a working knowledge and understanding of entire World Academy of Safety & Health (WASH) lifeguard certification program.

**S1** – able to teach pool lifeguard, waterfront lifeguard and waterpark lifeguard courses

**S2** – able to teach pool lifeguard, waterfront lifeguard, waterpark lifeguard and lifeguard instructor S1 courses

**S3** – able to teach all World Academy of Safety & Health (WASH) programs

**PARTICIPANT COURSE MATERIALS/EQUIPMENT:** World Academy of Safety & Health (WASH) Lifeguard Instructor Manual (free electronic or paid paperback); World Academy of Safety & Health (WASH) Pool Lifeguard Student Manual (free electronic or paid paperback); World Academy of Safety & Health (WASH) Waterpark Student Manual (free electronic or paid paperback); World Academy of Safety & Health (WASH) Waterfront Lifeguard Student Manual (free electronic or paid paperback); hip pack with CPR pocket mask, basic first aid supplies, whistle and gloves.

**CERTIFICATION PERIOD:** Two (2) year from the date of completion of the certificate with a thirty (30) day grace period to be eligible for a recertification or challenge course (lifeguards should not be considered certified during the grace period).

**DELIVERY:** Delivered as a blended format or online course.

**AVAILABLE:** English and Spanish



**NOTES:** 1.) If the WASH Lifeguard Instructor candidate does not currently hold an ASHI Instructor certificate, the ASHI Instructor Development Course (IDC) must be included as part of the WASH Lifeguard Instructor Cross-Over course (at an additional fee). Once the IDC is successfully completed, the instructor must either align with an ASHI Training Center or apply to become an ASHI Training Center; 2.) The WASH Lifeguard Instructor must either hold a current and verifiable provider-level certificate or have experience for the specialty lifeguard course he/she is teaching.
